

ORDINANCE NO. 608

AN ORDINANCE AMENDING THE 2021 LICENSE FEE(S) FOR ON-SALE LICENSES, SPECIAL LICENSES FOR SUNDAY SALES & TAPROOM LICENSES

Findings and Purpose:

WHEREAS, Minnesota governor has declared a peacetime state of emergency due to rapid community transmission of a deadly virus known as COVID-19.

WHEREAS, to stem the spread of COVID-19 during the referenced peacetime emergency, the governor has issued several executive orders which have limited or outright prevented restaurants, bars, and taprooms from in-person service.

WHEREAS, the limitations under the referenced executive orders have resulted in on-sale liquor license holders (pursuant to city ordinance 615.02(b)), special license holders for Sunday liquor sales (pursuant to city ordinance 615.02(d)) and Taproom License holders (pursuant to city ordinance 615.02(f)) from being unable to utilize said licenses.

WHEREAS, accordingly, the City anticipates greatly reduced costs and time necessary to investigate and enforce the referenced licenses for 2021, and desires to reduce the license fees for the referenced licenses to \$0.00 for the year 2021.

The City Council of Glencoe, Minnesota ordains:

Section 615.05(a) shall hereby read as follows:

The annual license fee for "On Sale" license shall be \$3000. The annual license for an "On Sale Club" license shall be \$100. The annual license fee for a "special license for Sunday Liquor Sales" shall be \$200. Sunday Liquor Sales may only be made between the hours of 10 o'clock a.m. and 12 o'clock midnight, except that the council may by resolution extend the closing hours to 1:00 a.m. Monday morning, when in the council's judgment there is a special event or holiday which justifies extended hours. Such a resolution adopted by the council to extend hours shall be effective only as to the single date set forth in the resolution. Such resolution shall be adopted at least 15 days prior to the date upon which it will be effective, and all Sunday liquor sales license holders shall be provided with notice by the City Administrator of the content of each such resolution. Notwithstanding the forgoing, for the year 2021 and only for the year 2021, the annual license fee for "On Sale" and "special license for Sunday Liquor Sales" license(s) shall be \$0.00 each, respectively.

Section 615.02(f)(iv) shall hereby read as follows:

The annual license fee shall be set in accordance with M.S. 340A.408 and shall be the same as imposed under Section 616 of this Chapter for On-Sale Nonintoxicating Malt

Liquor, as it may be amended from time to time. Notwithstanding the foregoing, for the year 2021 and only for the year 2021, the annual license fee for “Taproom Licenses” shall be \$0.00.

Effective date. This ordinance becomes effective from and after its passage and publication.
