GLENCOE CITY COUNCIL MEETING MINUTES MARCH 1, 2021 7:00 P.M.

CALL TO ORDER/PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE

Mayor Voss called the regular meeting to order at 7:00 p.m. Members present: Olson, Schrupp, Lemke, Neid and Robeck. Also present: City Administrator Larson, City Attorney Ostlund, Assistant City Administrator Neumann, Finance Director Trippel, PWDs Voigt and Schreifels and Police Chief Padilla.

Motion to approve the consent agenda as presented entered by member Robeck and seconded by member Neid. All members voted in favor.

BIDS AND QUOTES:

A. LAWN MOWER QUOTES

Jamie Voigt, PWD Streets and Parks reviewed quotes for replacement of two lawnmowers. Low quote from Kranz Lawn and Power of Hutchinson for 2021-72 inch deck EXMark commercial mowers with EFI for \$3500.

Discussion and questions led to a motion by Councilor Olson to approve the quote of Kranz Lawn and Power for \$3500 with replacement in 2022 for \$1500 per mower. Councilor Lemke seconded. Motion carried in a 4 to 1 vote with Neid entering the no vote.

REQUESTS TO BE HEARD:

A. LIGHT & POWER COMMISSION UPDATE

Dave Meyer, Manager, gave an update to the council on a proposed lease on a one acre parcel west of the Armstrong substation to BIT49 which processes bit coin

transactions. BIT49 requires a large, steady load of electricity. The business will have minimal staff on site, will be fan cooled, and will have fiber optics installed for their data transmission needs.

B. EXTEND COVID 19 LEAVE POLICY TO JUNE 1, 2021

It was recommended to consider to extend the COVID 19 Leave Policy of up to 80 hours until June 1, 2021. The city council had extended it to March 30th. This will give employees the opportunity to receive the vaccination.

Councilor Neid motioned to extend the leave time up to 40 hours. A second was not entered. Motion failed.

Councilor Olson motioned to extend the COVID 19 leave policy up to 80 hours and until June 1, 2021 giving the employees the opportunity to receive the vaccination. Councilor Robeck seconded the motion. Motion carried in a 4 to 1 vote with Neid entering the no vote.

Assistant City Administrator Lynn Neumann provided an update on the Comprehensive Plan. 33 community members attended the two virtual open houses held on February 18th. Motion entered by Councilor Neid and seconded by Councilor Schrupp to enter into a Letter of Intent to sell property at 13th Street and Hennepin Avenue, PID #22.060.1203, for \$10,000 with Standard Holdings, LLC. All members voted in favor.

Mayor Voss re-opened the regular meeting.

ADJOURN: Approximately 8:00 p.m. Mayor Voss called for adjournment. Councilor Schrupp entered that motion with Councilor Neid seconding. All members voted in favor.
