Approve Resolution 2024-04 Requesting 2024 Street Funds Advance for Municipal State Aid Street Bonds of 2016 – Justin Black, SEH City Engineer reviewed the request of MNDOT State Aid Office for the City to request an annual appropriation for the Debt Service on the 2016 Armstrong Avenue Project.

Motion: Olson, seconded by Lemke to approve Resolution No. 2024-04: and upon a roll call vote, the following voted Aye, Hueser, Rivera, Olson, and Lemke. The following voted nay, none. Whereupon resolution 2024-04 was declared adopted and approved.

RESOLUTION NO. 2024-04 MUNICIPAL STATE AID STREET FUNDS ADVANCE

WHEREAS, the Municipality of Glencoe constructed Municipal State Aid Street (MSAS) Project 226-115-01 in 2016 utilizing State Aid Bonds (issue date 05/18/2016) and the annual repayment of principal will require State Aid funds in excess of those available in its State Aid Construction Account, and

WHEREAS, said municipality utilized State Aid Advance Funding for completing CSAH 15 /Morningside Avenue Project in coordination with McLeod County, which includes SAP 043-615-013 (CSAH 15) and 226-103-002 (16th Street MSA route), and

WHEREAS, said municipality proceeded with the construction of said Project 226-115-001 through the use of bonds and will now require an advance from the Municipal State Aid Street Fund to supplement available funds in their State Aid Construction Account for the annual payment of bond principal, and

WHEREAS, the advance is based on the following determination of estimated expenditures:

Unencumbered Balance Available 12/31/2023 \$(250,99)
Advance Amount (amount in excess of acct balance) \$ 105,000

WHEREAS, repayment of the funds so advanced will be made in accordance with the provisions of Minnesota Statutes 162.14, Subd. 6 and Minnesota Rules, Chapter 8820.1500, Subp. 106, and

WHEREAS, the Municipality acknowledges advance funds are released on a first-comefirst-servebasis and this resolution does not guarantee the availability of funds.

NOW, THEREFORE, Be It Resolved: That the Commissioner of Transportation be and is herebyrequested to approve this advance for financing approved Municipal State Aid Street Project of the Municipality of Glencoe in the amount of \$105,000. I hereby authorize repayments from subsequent accruals to the Municipal State Aid Street Construction Account of said Municipality from future yearallocations until fully repaid.

Motion: Lemke, seconded by Hueser to approve the Third reading of Ordinance No. 624.. All in favor, the motion carried.

ORDINANCE NO. 624

AN ORDINANCE OF THE CITY OF GLENCOE, MINNESOTA, AMENDING VARIOUS SECTIONS OF THE CITY CHARTER:

THE CITY COUNCIL OF THE CITY OF GLENCOE ORDAINS (new material is underlined)

SECTION 1. That City of Glencoe Home Rule Charter, Chapter III – City Council, Section 3.01 – General Powers, be amended as follows:

Section 3.01 General Powers. The legislative power and authority of the City of Glencoe shall be vested in the City Council as provided by this Charter and by the laws and Constitution of the State of Minnesota. The City Council shall have charge of the care, control and supervision of all public streets, alleys, buildings, and grounds of the city, the care and supervision of which are not by this Charter vested in any other board or officer of the city. The City Council, except as in this Charter otherwise provided, shall have the general management and control of the finances and all the property of the city, and shall have full power and authority to make, amend or repeal all such ordinances or resolutions as it shall deem expedient for the government and good order of the city, for the protection of the public and public health, comfort, and safety, for the suppression of vice and for the prevention of crime. It shall have power and authority to declare and impose penalties and punishments for the violation of ordinances and resolutions and to enforce the same against any person who may violate the same, and all such ordinances and resolutions, not inconsistent with laws and Constitution of this state or of the United States, of this Charter, are hereby declared to have full force and effect as the law of the city. In addition, the Council shall have the specific powers as now provided by Minnesota Statutes as the same may hereafter from time to time be amended, together with such other specific powers as are from time to time granted by the Constitution and laws of the State of Minnesota to city councils of cities of the class of the City of Glencoe. The City Council shall have the power and authority, to be exercised by the four-fifths vote of the Council, to establish a nursing home and home for the aged, the establishment and operation of which is hereby specifically declared to be a public purpose.

SECTION 2. That City of Glencoe Home Rule Charter, Chapter VII – Departments of the City, be amended as follows:

Section 7.02 <u>Organization of Fire Department and Control of Property.</u> There shall be a fire department in the City of Glencoe, over which the Mayor shall have the power to exercise authority. In addition to appointing employees of the fire department, the Mayor appoints, subject to confirmation of a majority vote of the Council, any volunteers of the fire department. The Council shall provide such real and personal property for the use of the fire department as the Council shall deem necessary.

Section 7.03 Officers of Fire Department. Repealed by Ordinance No. 624, dated February 20, 2024.

Section 7.04 <u>Powers and Duties of Chief</u>. The chief of the fire department shall be the general superintendent of the fire department and all real and personal property assigned to the department use. The Fire Chief shall direct and control the training of <u>employees and volunteers</u> of the department and all activities <u>employees and volunteers</u> of the department and other individuals engaged in fighting fires. The Fire Chief shall make an annual report of the activities of the department to the Mayor and Council, together with such other reports as may be required by law.

Section 7.05 <u>By-Laws, Rules and Regulations of Fire Department.</u> Repealed by Ordinance No. 624, dated February 20, 2024.

Section 7.06 Out of Town Calls. Repealed by Ordinance No. 624, dated February 20, 2024.

Section 7.07 Destruction of Buildings. Repealed by Ordinance No. 624, dated February 20, 2024.

Section 7.08 <u>Additional City Departments - Authority to Establish.</u> The City Council shall by ordinance establish such departments as the Council shall deem necessary.

Section 7.09 <u>Appropriations and Expenditures of Funds.</u> The City Council may appropriate money from the general fund or other funds <u>through its annual budgeting process in order to fund the various departments and associated services of the City</u>, and subject to the approval by the City Council <u>and the uniform municipal contracting law, Minnesota Statutes, section 471.345</u>, the <u>various departments</u> may be given the power to expend such monies as the City Council deems its functions.

SECTION 3. That this ordinance shall take effect from and after 90 days following its passage and publication in accordance with Minn. Stat. § 410.12, subd. 7.

Adopted the 20th day of February, 2024, by the City Council of the City of Glencoe, Minnesota.

E. Third Reading of Ordinance 625 to amend the City Charter relating to the appointment of members of the Light and Power Commission – City Attorney Ostlund reviewed the final reading of Ordinance 625.

Motion: Hueser, seconded by Olson to approve the third reading of Ordinance No. 625. All in favor, the motion carried.

ORDINANCE NO. 625

AN ORDINANCE AMENDING THE CITY OF GLENCOE CHARTER, PARTICULARLY SECTION 9.02

RELATING TO THE APPOINTMENT, QUALIFICATION OF COMMISSION MEMBERS FOR RESIDENTIAL CUSTOMERS RESIDING IN THE GLENCOE LIGHT AND POWER SERVICE TERRITORY

THE CITY COUNCIL OF THE CITY OF GLENCOE ORDAINS:

Section 1: Section 9.02 of the City of Glencoe Charter shall be amended to read in its entirety as follows:

Section 9.02 Appointment, Qualification and By Whom Made. Glencoe Light and Power

Commission shall consist of five members, four (4) of whom shall be qualified voters of the City

of Glencoe, one (1) member may reside in the Glencoe Light and Power service territory, all must
be residential customers of the Glencoe Light and Power Commission, and shall be appointed by
the City Council for the terms and at the times as herein set forth.

Section 2: This ordinance shall take effect 90 days following its passage and publication.

Adopted this 21st day of February, 2024.

F. Rezoning Request of Dollar General/Overland Group on land owned by Seneca Foods – Planning Commission Recommend rezoning the property, owned by Seneca Foods, and under a purchase agreement with Overland Group for the Dollar General to B-1, Commercial.

Motion: Hueser, seconded by Lemke to approve the Rezoning request of Overland Group. All in favor, the motion carried.



What is MS4?

A municipal separate storm sewer system (MS4) is a conveyance or system of conveyances (roads with drainage systems, municipal streets, catch basins, curbs, gutters, ditches, man-made channels, storm drains, etc.) that is also:

- Owned or operated by a public entity (which can include cities, townships, counties, military bases, hospitals, prison complexes, highway departments, universities, sewer districts, etc.)
- Designed or used for collecting or conveying stormwater
- Not a combined sewer
- Not part of a publicly owned treatment works (MPCA)

Glencoe MS4 Permit and SWPPP (Stormwater Pollution Prevention Plan)

The MS4 general permit is designed to reduce the amount of sediment and other pollutants entering state waters from stormwater systems. Entities regulated by the MS4 general permit must develop a stormwater pollution prevention program and adopt best practices

The Stormwater Pollution Prevention Plan (SWPPP) is your plan and guide to understanding and managing stormwater



Why does Glencoe require an MS4 Permit?

MS4s in Minnesota must satisfy the requirements of the MS4 general permit if they are at least one of the following:

- Located in an urbanized area and used by a population of 1,000 or more
- Owned by a municipality with a population of 10,000 or more
- Have a population of at least 5,000 and the system discharges to specially classified bodies of water.



Environmental Harm



- Storm Sewers deliver rain and pollution directly to our lakes and rivers.
- Excess amounts of chlorides from salt, heavy metals, nitrogen and phosphorus from fertilizer runoff can create dangerous algae blooms, fish kills, and dangerously negative effects to the biodiversity of the ecosystem.
- Erosion can occur from the destruction of shoreline plant life and flooding.

Reducing Storm Water


- Glencoe participates in a rain barrel program along with the cities of Hutchinson and Wilmar.
- The program consists of residents purchasing a rain barrel from the city at a charge of \$30. The barrel comes with hardware to attach to the downspout to catch the rainwater from the roof and gutter system
- In addition, the city is implementing an adopt-a-catch basin program in the spring of 2024 as well as investigating implementation of a rain garden program.

Simple Steps To Better Water Quality

- Reduce salt usage on driveways and roadways in the winter
- Pick up and dispose of pet waste into trash bins or designated pet waste disposal containers
- Utilize the Rain barrel program
- Implement a bioinfiltration (rain garden) along impervious surfaces
- Reduce fertilizer usage or be mindful of applications near impervious surfaces

What is a Catch Basin and What do they do?

• Catch basins are the first step in the collection of stormwater. Catch basins work in a similar fashion to the drains in your house. Stormwater flows off streets and other impervious surfaces where the catch basins collect and divert flows through a series of pipes that discharge the stormwater into the Buffalo Creek watershed, or a pond designed to hold stormwater.



Where are Catch Basins Located?

- Catch basins are located within the curb, or gutter, of the street.
- Grids on top of the catch basin are designed to filter out large debris from entering the storm sewer system.

Why Adopt a Catch Basin?

- Adopting a catch basin helps the city monitor the health and operation of our storm sewer system. The public works
 department does a very good job of monitoring the system, however, during large weather events, it can be a daunting
 task to monitor the entire system at once.
- By adopting a catch basin, you can play a vital role in the quality of services that our public works department can provide.
- This simple act of citizen engagement affords the public works department to either respond quickly to an emergent issue within the storm system, as well as have a sense of comfort that they can address other concerns knowing that they will be informed immediately if an emergent issue arises in your catch basin.

What is Required if I Adopt a Catch Basin?

- Monitor the debris that can gather on top of the catch basin. If it is minor build up, rake the debris off and notify the
 public works department that there was debris and that you cleaned it off. By doing this we will be able to monitor the
 amount of collection and prioritize catch basins that the city should be monitoring closely. If the debris is a considerable
 amount, simply contact us and we will provide cleaning services,.
- Monitor the catch basin during weather events to ensure proper drainage, if there is an issue, notify the public works
 department immediately.
- Using a flashlight, and not removing the grate, inspect to make sure the catch basin is free of debris internally. If debris exists, contact public works for service.

What is Required if I Adopt a Catch Basin?

- Ensure that all proper labels are present and legible.
- Put your own small artwork on the catch basin! You will be permitted a small section
 of the catch basin to create a design based on environmental impacts of stormwater
 collection, water and/or environmental conservation. All artwork will require approval
 from City Council prior to implementation. This is NOT a requirement, just a bonus!

How do I Adopt a Catch Basin?

- Residents wishing to adopt a catch basin will need to contact Public Works Director Mark Lemen.
- Residents must sign the Adopt a Catch Basin pledge agreeing to the minimum requirements of the program.
- Pledges will be renewed annually, and residents will receive a certificate of appreciation as well as be recognized at the city's annual MS4 public hearing in March.

Motion by Amanda, seconded by Noel to approve Jim as the chair for the park board for the 2024 year. All present voted aye. Motion carried.

Adopt Minutes:

Motion by Amanda, seconded by Jim to approve the minutes from October 25, 2023. All present voted aye. Motion carried.

Park Board Applications:

Mike Long and Matt Roberts did not renew their terms with the park board. The park board received 4 applications for interest in the 2 open positions. The applicants were as follows:

Dennis Wolter - Only interested in park board

Lynda Wagener - Only interested in park board

Deb Krone – Interested in library board as first choice and park board as second choice

Derek Rosenwald – Interested in park board, planning & industrial commission, and economic development commission

It was discussed if the other board seats were still open or filled but that was unknown at the time of the meeting.

Lynda Wagoner was in attendance at the meeting and took the opportunity to introduce herself and tell the board why she is interested in the position. *Motion by Amanda, seconded by Noel to recommend the appointment of Lynda Wagoner to the park board pending City Council approval. All present voted aye. Motion carried.*

The park board will request city staff to reach out to the other applicants to see if they are still interested and if so request them to come to the March meeting so a selection can be made on the remaining open seat.

Pickleball Installation:

Updated quotes were provided from C&C Courts for modular surface versus color coat surface for the pickleball courts. The modular surface is about \$9000 more than the color coat surface but the life expectancy is much longer and the warranty period is 15 years compared to a 2-year warranty and a 5-to-7-year replacement expectancy. Discussed concrete thickness options and all agreed the thicker option would be more durable and the better option. Also discussed galvanized versus black fencing options. The preliminary range of the project is \$120,000 to \$150,000 for 4 courts. There has been \$14,000 received in donations which are taken into consideration with the Park Improvement Fund balance of \$178,000. Knife River also offers a Community Grant in May that could be between \$500 to \$5,000. Very optimistic of the likelihood of getting granted something due to the community involvement of the project. The park board does support this project and think it is important to keep the project moving forward. Additional funding sources will need to be identified to close any gaps in the project and private donor contributions are expected but it is unknown to what extent . *Motion by Jim, seconded by Amanda to*

commit \$100,000 of funds from the Park Improvement Fund towards the pickleball project. All present voted aye. Motion carried.

Park Shelter Update:

The online shelter rental resource is now available online.

Other:

Amanda brought up looking into the MN DNR Grant for the restroom portion of the Oscar Olson project if not for this year potentially a future year when we are more financially prepared for the restroom component of the project. The application period closes April 1, 2024 and is a matching grant up to \$350,000. Grant selections would be made in the summer of 2024. Work cannot be started until after the grant is awarded so the pickleball courts and soccer fields would not be a viable option for this. Restrooms are an eligible recreation support facility and eligible for grant proceeds when a sport court, trails, and/or playgrounds are also a component of the project. The application period for 2024 would recommend 2025/2026 construction dates.

Jamie's Report:

- -Staff continues to work on refurbishing the picnic tables.
- -Clean up of the parks is expected to begin before the end of March.
- -The shed that was brought out to Oak Leaf Park will have steel put on the roof and the door frame repaired.
- -The Rotary is taking on the dog park. The Rotary expects to completely fund the project and/or fundraise for the project.
- -Staff will seed the expected dog park area to get the grass to proper consistency for the amount of dog traffic that would be expected one day.
- -Soccer fields are also priority of the Oscar Olson project and an estimated cost of \$35,000. There is a group interested in donating goals in order to hold their practices at the park.
- -Staff will continue to work with interested parties on the memorial benches and will get the concrete bases put into place for the benches.

Adjournment:

Motion by Amanda, seconded by Noel to adjourn the February 28, 2024 park board meeting. All present voted ave. Motion carried.

Good Afternoon,

I am Jonathan Osthus with the Minnesota Department of Agriculture (MDA) and am the technical assistance coordinator for emerald ash borer (EAB) in Minnesota. We have detected an infestation of EAB in Glencoe after MDA inspectors identifed several infested trees when completing early detection surveys in the area. The infestation was found on the northside of Hwy 212 just east of Hennepin Ave N (44.76673, -94.15101).

Emerald ash borer kills ash trees. All ash trees (*Fraxinus spp.*) are susceptible to EAB. The location of the infested trees will be visible on our <u>EAB status map</u> if you zoom into the city in the next several days. The map has a several mile buffer around known infested points called the "generally infested area" and this means any ash tree within that area has a high likelihood of having EAB at some level whether showing signs of infestation or not.

One of the most important things will be to make sure residents are aware that EAB is in the area and to begin making decisions on what they'd like to do with their ash trees. If residents want to save their ash

trees, then they should begin having their trees treated with insecticide next spring/summer. More information for homeowners can be found at https://www.mda.state.mn.us/eab-info-homeowners. Hennepin County has also created a useful flow chart for residents that lays out a decision guide for managing ash trees.

The basic options for a property owner are the following:

- If the ash tree still looks healthy enough after leafing out (no more than 30% canopy decline), you can begin having it treated with insecticide to begin protecting it this spring/summer. This is an annual or biennial expense and best to have a professional tree care company with a certified arborist on staff assess the health of the tree and apply the treatment. If the tree is over 15" in diameter at breast height it is important to have a licensed pesticide applicator treat the tree. The chemicals available to the average homeowner typically aren't rated for trees that size or larger. Homeowners guide to insecticide selection
- If the tree is past the point of being a good candidate for treatment or would prefer not to go that route, plan to do removals during fall, winter, or early spring. Try to avoid doing any pruning or removals during the summer months (May-Sept) when EAB is actively flying around. Ash trees become very brittle and hazardous quickly after they die and that can greatly increase removal costs depending on where it happens to be located in the yard. It typically takes about 2-3 years for signs of infestation to become initially visible (i.e. woodpecker damage in branches 2-6 inches in diameter) and a total of 5-6 years for EAB to kill the tree.
- If the ash trees are in a natural area where they don't pose hazards to persons or property, they can be left to die and fall apart.
- As for the wood, it is best if it can be kept as close to where it was cut as possible. You can save
 it for firewood and burn on-site, bring to closest tree waste disposal site, or have a tree care
 company haul it if you hire one to cut the tree. It is just important that the wood doesn't get
 hauled outside of the known infested area and emerald ash borer <u>quarantine restrictions</u> are
 followed.







What is the Risk to Your Tree(s)?

Trees need to be protected with insecticides when emerald ash borer (EAB) populations are abundant enough in an area to cause significant injury in the next year or two. Deciding when to use insecticides to protect trees from EAB depends on the EAB abundance in the area and how much risk you are willing to tolerate regarding the tree or trees in question. To learn about EAB abundance in your area:

- Check the Minnesota Department of Agriculture's (MDA)
 Interactive EAB Survey Map for the locations of known infestations in Minnesota at: www.mda.state.mn.us/eab
- Check with your local government or the MDA about monitoring efforts in your area.
- Learn how to recognize symptoms of EAB infestation and keep an eye on the trees in your neighborhood.



Treatment Will Likely Need to be Repeated

Insecticides only work while they are present in the tree, and products are generally labeled for one to two years of effectiveness. Treatment will need to be repeated to protect trees if EAB are still abundant enough in an area to cause significant injury when the effective period ends. EAB could remain at damaging levels in an area for several treatment cycles or return to damaging levels in the future.

Remove and Replace Ash Trees on Your Property

It may be more cost effective to replace a small or struggling ash tree than to pay the cost of ongoing treatments. In addition, trees in poor health are not likely to respond well to treatments. Do not treat trees showing more than 50 percent canopy decline; these ash trees are unlikely to recover even if treated. Check with a certified arborist or licensed professional pesticide applicator to compare costs and benefits of treatment versus removal.

Check Your Calendar - Timing is Everything

To ensure the insecticide is distributed throughout the tree to control EAB, soil-applied insecticides available to homeowners are most effective when applied mid-to late spring or in mid-fall. Do not apply products when the soil is frozen. Refer to the table on page 2 for more information on the timing of different insecticide options. Weather conditions or other factors may alter these recommendations. Read pesticide labels carefully. The label is the law.

Contact a Certified Arborist or City Forester to Evaluate Treatment Options

When contacting a professional, consider the following:

- Your city or township may have requirements or restrictions related to
 the treatment of EAB, especially for ash trees located on city property,
 which may include trees planted on or near boulevards or sidewalks.
 Check with your city's park and recreation or forestry departments.
- If hiring a professional, ask to see their licensure as a Commercial Pesticide Applicator for category "E: Turf and Ornamentals."

Treatment of Large Ash Trees

Treatment options available to homeowners for treating large ash trees require carefully following application instructions to avoid unintended environmental impacts. In general, consider having large ash trees (those greater than 48 inches in circumference, as measured 4 % feet above ground level) treated by a professional. Check specific pesticide product labels for tree size requirements.

Insecticide Treatment Options

Always read and follow the label directions for the specific pesticide product being used.

Homeowners do not have access to some of the products marketed to professionals and arborists.

This document does not endorse the listed insecticide products over other options, and includes only the most common treatments. For product efficacy questions, consult your local Extension specialist.

Water Quality and Pollinator Considerations

When using pesticides, read and carefully follow all label directions. Use in accordance with all precautionary statements, label directions, and applicable state and federal regulations.

Aquatic Considerations:

- To protect the environment, do not apply these pesticides directly to water or where surface water is present; prevent pesticide entry or runoff into storm drains, drainage ditches, gutters, or surface water; consider the risks of groundwater contamination.
- · Trunk injections have fewer concerns for water quality, unless accidentally spilled.
- Emamectin benzoate is highly toxic to mammals, fish, and aquatic invertebrates.
- · Neonicotinoids are highly toxic to aquatic invertebrates and have the potential to leach into the groundwater.

Pollinator Considerations:

When using pesticides, take steps to prevent exposure to bees and other insect pollinators. Look for the bee hazard
icon on the label, and in Directions for Use section of the pesticide label, check instructions for each application site
for any additional specific use restrictions and instructions to protect bees and other insect pollinators.



- To protect pollinators, prevent pesticide drift from foliar applications onto beehives or to off-site, pollinator-attractive habitat areas; prevent drift of insecticides to blooming, pollen-shedding, or nectar-producing plants.
- Systemic insecticides can move into plant pollen and nectar resulting in exposure to pollinators. For soil injection and drenching
 applications to trees, protect pollinators by not planting pollinator-attractive habitat within the area of treatment.

Follow These Recommendations to Protect Water Quality

The MDA conducted a special registration review of EAB insecticides in 2011. The review concluded that insecticides commonly used to control EAB are not likely to result in unreasonable risks to human health or the environment when used according to label directions.


In some cases, the following recommendations may refer to mandatory label use requirements:

Generally, professionally applied trunk injections have fewer concerns for water quality.

For soil-applied products and bark sprays, the following considerations are important:

- Properly prepare application site and apply product according to label instructions. Consider avoiding use
 within 25 feet of water bodies. This includes streams, lakes, ponds, wetlands, or conduits to surface water
 or groundwater such as street curbs, storm drains, sumps, or well heads.
- · Do not apply when heavy rainfall is expected within 24 hours of the planned treatment.

Situations that could cause soil-applied insecticides to wash away or leach, potentially contaminating water resources



Making Sense of EAB Insecticide Labels

The label is the law! Always read, understand, and follow the label directions for the specific insecticide product being used.

Selecting and Using an Insecticide:


- Look for products marketed to control emerald ash borer (see Products Table on page 2).
- Read the Environmental Hazard Statements on the insecticide label.
- · To facilitate uptake, soil-applied insecticides should be applied when the soil is moist but not saturated or excessively dry.
- For soil drenches, remove or rake any mulch or dead leaves, then pour the insecticide solution directly onto soil.
- Do not allow children and pets to re-enter treatment area until sprays or drenches have dried.
- · Store insecticides where children cannot reach them.
- Many homeowner products only allow one soil drench application per year.
- Some products have maximum per acre use limits. Do not apply more than the approved labeled rate.

Disposing of an Insecticide:

- When using the last of a liquid insecticide, triple-rinse the container before disposal, then apply the rinse water as you would apply the insecticide.
- Unusable and unwanted insecticides must be disposed of according to the label directions, or at a county household hazardous waste disposal event.
- · It is illegal to bury or burn an insecticide.

Measure Your Ash Trees

It is important to measure your ash tree to determine the appropriate treatment and to accurately follow the use instructions on insecticide labels.
